NOTICE OF SUPPLEMENTAL AUTHORITY

Plaintiff Animal Legal Defense Fund (ALDF) file this Notice of Supplemental Authority in support of is Opposition to Defendant Hormel Foods Corporation's Motion to Dismiss. The attached decision, *Walters v. Vitamin Shoppe Industries, Inc.*, __ Fed. App'x __, 2017 WL 3264035 (9th Cir. Aug. 1, 2017), was decided after briefing on Hormel's Motion to Dismiss was completed.

Walters involved a consumer claim that a product was misrepresented. *Id.* at *2. The defendant contended that the plaintiff's misrepresentation claim could be defeated because reviewing the fine print on the back of the product package would have dispelled any misunderstanding. *Id.*; *compare id. with* Hormel's Reply Brief in Support of Its Contested Motion to Dismiss Plaintiff's Complaint, at 14 (July 27, 2017). The U.S. Court of Appeals for the Ninth Circuit rejected that argument outright, explaining that "[c]onsumers review small print on a product's label to learn additional details about a product, not to correct potentially misleading representations on the front," and holding that the plaintiff "did not have a duty to validate claims on the front of a product's label by cross-checking them against information contain in small print

on the back." Walters, 2017 WL 3264035, at *2 (following Williams v. Gerber Prods. Co., 552

F.3d 934, 939-40 (9th Cir. 2008)).
